
**Micro Enterprises:** The specifications made for micro enterprises can be explained as follows: Investment in Plant, machinery and equipment is not more than Rs. 1 crore and the annual turnover cannot be more than Rs.5 crores. This is the latest definition and investment criteria for micro units.

**Small Enterprises:** In the same way investment limit and other specifications are given as below in case of small enterprises. Investment in Plant & machinery and equipment cannot be more than Rs 10 crores. And similarly, the annual turnover also cannot be more than Rs. 50 crores.

**Medium Enterprises:** Under medium enterprises the investment in Plant & machinery and equipment cannot be more than Rs. 50 crores. And the annual turnover limit also cannot be more than Rs. 250 crores. The is also showed in the figure as below:


